# Subject: Scrutinizer's Report on Postal Ballot and E-voting Process conducted pursuant to the provisions of Section 110 of the Companies Act, 2013 ("the Act") read with Rule 22 and Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended.

The Board of Directors of Future Retail Limited (hereinafter referred to as (the "Company") at its meeting held on 14<sup>th</sup> November, 2018 had appointed me as the Scrutinizer for the Postal Ballot / Remote Electronic Voting ("e-voting") pursuant to Section 108 & 110 of the Act read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 (including any statutory modification or re-enactment thereof for the time being in force) and other applicable provisions, if any and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "Listing Regulations"), for the resolution in respect of the matter as set out in the Postal Ballot Notice dated 24<sup>th</sup> December, 2018 proposed to be transacted by way of postal ballot / e-voting ("Postal Ballot").

#### REPORT ON SCRUTINY

- The Company has appointed National Securities Depositories Limited ("NSDL") as the Service Provider, for the purpose of extending the facility of e-voting to the Members of the Company through their website <u>www.evoting.nsdl.com</u>.
- M/s. Link Intime India Private Limited is the Registrar and Share Transfer Agent ("RTA") of the Company.
- The cut-off date for determining Members for the dispatch of the Notice of the postal ballot was 21<sup>st</sup> December, 2018 (Physical & E-mail) and as on that date, there were 54,631 Members of the Company. The Company had sent the Postal Ballot Notice along with postal ballot form and e-voting details by E-mail to 44,850 Members, whose E-mail ID were registered with the Company / RTA. In respect of 9,781 Members, the Company had sent the notice of the postal ballot, postal ballot form along with self-addressed pre-paid postage Business Reply Envelope in physical form through speed post.





- The Company completed the dispatch of the postal ballot notices in physical form & E-mail to the eligible Members on 28<sup>th</sup> December, 2018.
- The notices sent (both through e-mail and physical form) contained the detailed procedure to be followed by the Members who were desirous of casting their votes electronically as provided in the Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time.
- The cut-off date for the purposes of identifying the Members who will be entitled to vote on the resolution placed for approval of the Members was 21<sup>st</sup> December, 2018.
- The e-voting facility was kept open from 29<sup>th</sup> December, 2018 (9:00 a.m. IST) till 27<sup>th</sup> January, 2019 (5:00 p.m. IST).
- As prescribed under Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, the Company also released an advertisement in "The Free Press Journal" Newspaper in English language and in "Nav Shakti" Newspaper in Marathi language both dated 29<sup>th</sup> December, 2018. The notice published in the aforesaid Newspapers carried the required information as specified in the said Rule.
- The votes were unblocked on Sunday, 27<sup>th</sup> January, 2019 after 5:00 p.m. (IST) in the presence of two witnesses who are not in the employment of the Company and the details containing the list of Members who voted "for" or "against" the resolution was downloaded from the e-voting website of NSDL.
- All postal ballot forms received up to Sunday, 27<sup>th</sup> January, 2019, being the last date fixed by the Company for the receipt of the physical forms, were considered for my scrutiny. All votes casted on NSDL e-voting platform up to 5:00 p.m. (IST) on Sunday, 27<sup>th</sup> January, 2019 were considered for my scrutiny.
- The postal ballot forms which were incomplete and / or which were otherwise found defective have been treated as invalid and kept separately.
- Envelopes containing postal ballot forms returned undelivered were also not opened and they are separately kept.
- Thereafter, considering votes through e-voting and votes cast through postal ballot forms, the combined result of the voting is given below:
